

# CONTRACT

**THIS AGREEMENT**, made this Sixteenth Day of January in the year of Our Lord Two Thousand and Eight between the County of Salem, party of the first part, and **Certified Consultant Pharmacists, Inc.** party of the second part, for the provision of Pharmacy Consultant Services for the County of Salem.

**WITNESSETH**, that the said party of the second part for and in consideration of the payments hereinafter specified and agreed to by the party of the first part, hereby covenants and agrees to furnish and deliver all materials, to do and perform all the work and labor required to be furnished and delivered, done and performed in and about the County of Salem in conformity with the Supplemental Specifications hereto annexed, which were duly approved by Resolution of the said Salem County Board of Chosen Freeholders, adopted the Sixteenth Day of January in the year of Our Lord Two Thousand and Eight which said Supplemental Specifications are hereby made a part of this agreement as fully and with the same effects as if the same had been set forth in the body of this agreement.

The party of the second part agrees to make payment of all proper charges for materials and labor required in the aforementioned work and indemnify and save harmless the party of the first part, its officers, agents and servants and each and every one of them, against and from all suits and costs of every name and description, and from all damages to which said party of the first part or any of its officers, agents, or servants may be put, by reason of injury to the person or property of others resulting from the carelessness in the performance of said work or through the negligence of said party of the second part of through any improper or defective machinery, implements or appliances used by the party of the second part in the aforesaid work or through any act or omission on the part of the said party the second part, his agent or agents, or from an debts incurred by agents or subcontractors of the party of the second part.

It is understood and agreed that the determination of awards in this contract were based on submitted competitive proposals, and Pursuant to New Jersey State Law N.J.S.A. 19:44A-20.7 "Fair and Open Process" rules adopted by the Salem County Board of Chosen Freeholders. The Party of the Second Part will submit when required a Business Entity Disclosure Certificate for public inspection.



It is also agreed and understood that the acceptance of the final payment by the contractor shall be understood as a release in full of all claims against the County of Salem out of, or by reason of the work done and materials furnished under this contract.

It is further agreed that the party of the first part reserves the right to reduce or increase any or all of the quantities in each item at the unit price bid all accordance with the provisions of the attached Supplemental Specifications.


In consideration of the premises, the party of the first part hereby agrees to pay the party of the second part for said work when completed in accordance with the said specifications and within the time stated for the actual quantity of authorized work done under each item scheduled in the proposal at the respective unit prices bid therefore by the party of the second part, which payments shall be made in accordance with provisions of the attached specifications:



- A. For the purpose of providing Pharmacy Consultant Services as related to the Salem County Nursing Home. Expenses are not to exceed \$15,000 for the term of the contract.
- B. This contract commences, retroactively, to January 1, 2008 and will terminate December 31, 2008 with a one year renewal option. All Specifications and requirements become a part of this contract.
- C. This contract is to be binding upon the party of the first part, its successors or assigns and upon the party of the second part, Certified Consultant Pharmacists, Inc., 6 Colonial Way, Chatham, New Jersey 07928.
